Introduction

- Introduction is at least five sentences long (yes no)
- Starts with a thorough description of the crime scene (yes no)
- Talks specifically about what was encountered at the crime scene (yes no)
- Includes a claim answers all parts of question.
 - O You specifically stated what was the truth of the case (murder or suicide) (yes no)
 - O You make a case (state what you think happened and who did it-provide a suspect) (yes no)
 - O You state why additional evidence is necessary (yes no)
- Note: if you need to change anything about your claim so that it answers the prompt, it probably means you'll need to adjust your body paragraphs so they match up with the changes.

Body Paragraphs

First Body Paragraph

- The first body paragraph begins with a topic sentence that is a natural extension from the claim. It is introducing a sub-point of your claim and answers part of the prompt.
 - o It states what you think is the truth and outlines your case (yes no)
 - o It provides a suspect (yes no)
- It states what you think happened (yes no)
- It shows how what you think happened is possible by analyzing at least 4 pieces of evidence by giving rules (usually and generally statements) and conclusions you reached because of the evidence (yes no)
- At the end of the paragraph your theory seems plausible because you have fully analyzed evidence (yes no)

Second Body Paragraph

- The second body paragraph begins with a topic sentence that is a natural extension from the claim. It is introducing a sub-point of your claim and answers part of the prompt. This means it focuses on the second point of your claim.
 - o It states why additional evidence is necessary (yes no)
- The paragraph fully explains why at least three additional pieces of evidence are necessary (yes no)

• The paragraph goes into detail about why three different things are still needed (yes no)

Third Body Paragraph

- The third body paragraph begins with a topic sentence that is a natural extension from the claim. It is introducing a sub-point of your claim and answers part of the prompt.
 - o It states what other detectives think happened (yes no)
- Presents at least three pieces of evidence other detectives might use for suicide(yes no)
- Explains what is wrong with each piece of evidence (yes no)

Conclusion

- The conclusion rewords the claim. (yes no)
- Summarizes main points made (yes no)
- Makes a solid recommendation (yes no)
- The conclusion does not introduce any new information. (yes no)
